EXCITING NEW LOAN PRODUCTS

TCSECU will be offering two new loan products - Payday Alternative Loan and Private Student Loan.

PAYDAY ALTERNATIVE LOANS (PAL):

Members who have no credit or have credit challenges may qualify for our Payday Alternative Loan (PAL) program. PAL provides members with an alternative option to the high cost credit of Payday loans elsewhere.

These are small loans (max. \$400) with a short repayment period.

Payroll deduction or direct deposit is required before the loan is disbursed. The member will pay a disbursement fee of \$25 each time funds are disbursed.

Our regular unsecured loans will still be available to our membership.

COMING SOON: PRIVATE STUDENT LOANS:

The private student loan program provides an alternative to Stafford or Plus Student Loans. It is funded by TCSECU, not the government.

STATEMENTS OF ACCOUNT

As of July 1st, only share draft accounts and accounts with ACH (automated clearing house) activity will receive a monthly statement. All other accounts will receive a quarterly statement. For your convenience, at any time you may (8195) access your account activity on TCSECU's *FREE* online banking. SUMMER SKIP A PAY IS HERE

Need some extra money? Why not skip your August loan payment? Yes, we are offering Skip A Pay for the month of August and it's only \$25 per loan!

Skip A Pay eligibility:

Your loan may not be over 30 days delinquent within the last 12 months.

The \$25 processing fee may be made via TCSECU checking/savings account, cash or check.

Mortgage and Home Equity loans are not eligible for Skip A Pay.

Interest does accrue during the skip period.

Loan is extended out beyond the stated note and disclosure.

To take advantage of Skip A Pay, stop by our office, before July 31st to complete a Skip A Pay form. Summer Skip A Pay covers from the loan period from August 1st—August 31st.
